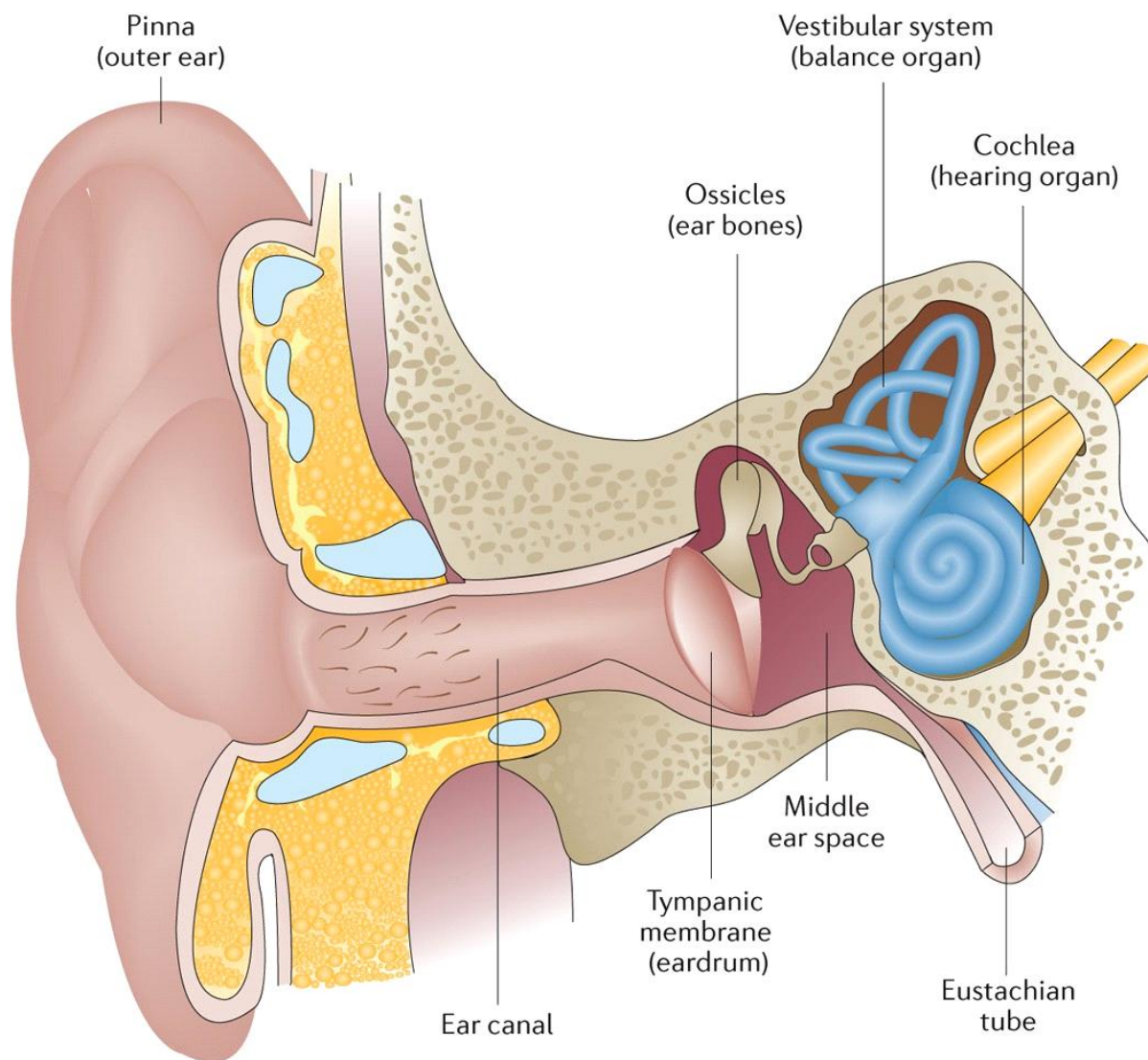

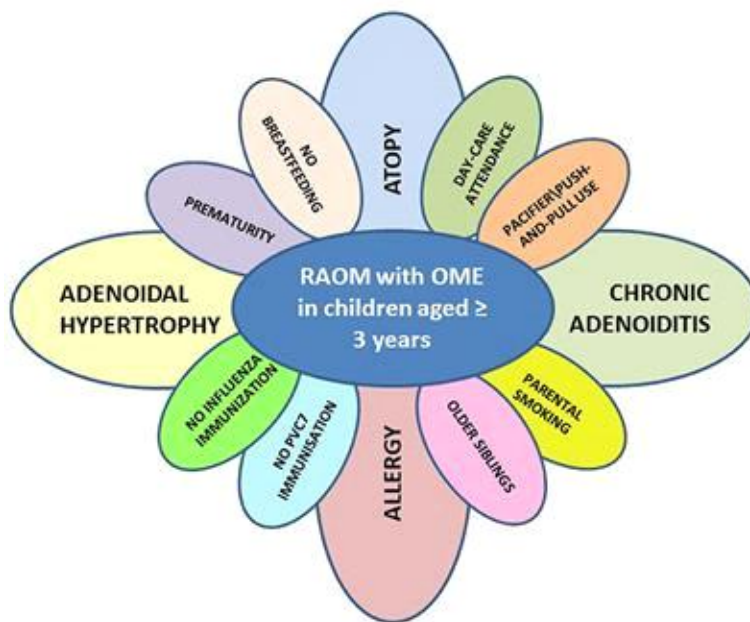
Shared Inflammatory Pathways:
